How returns are calculated

When the portfolio companies sell stock to other investors, H/F changes the price of the fund based on the portfolio companies' stock price

We issue dividends to shareholders after Mergers and Acquisitions (M&A's) or Initial Public Offerings (IPO's) of our companies

**Time to complete contracting of dealflow 12 months. Typical lock-in period 12 months. Time to IPO market 1 year. Total time of monies in Fund 5 years.*
