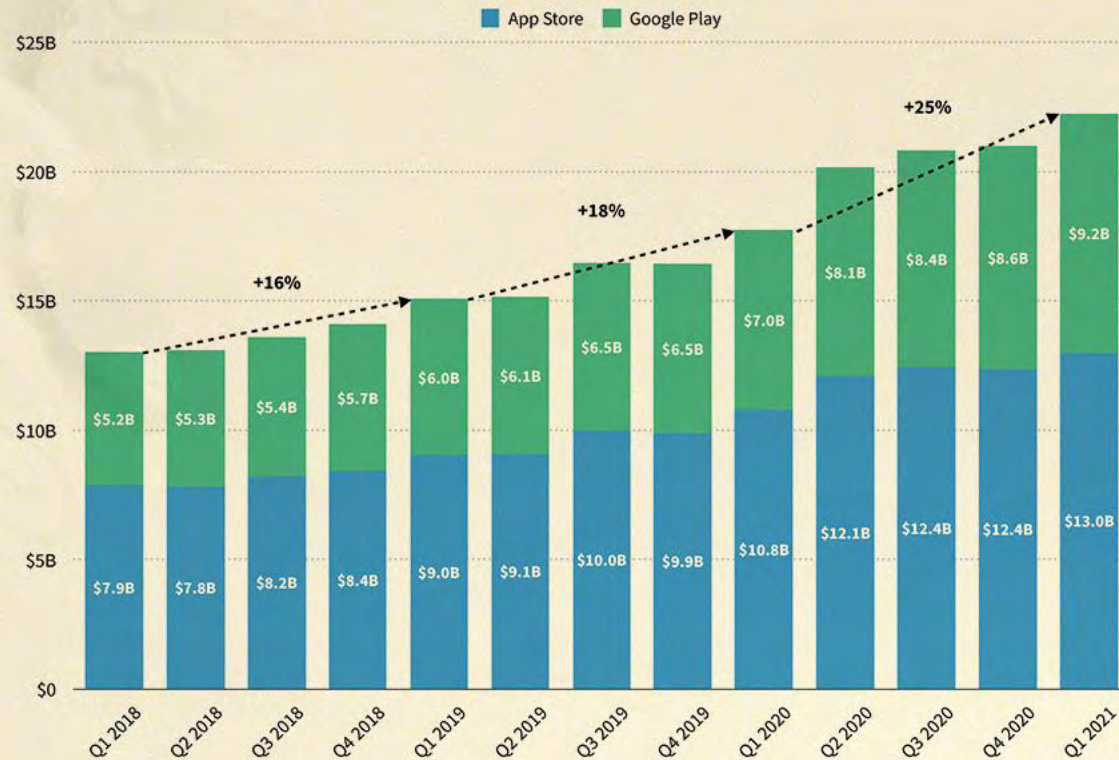

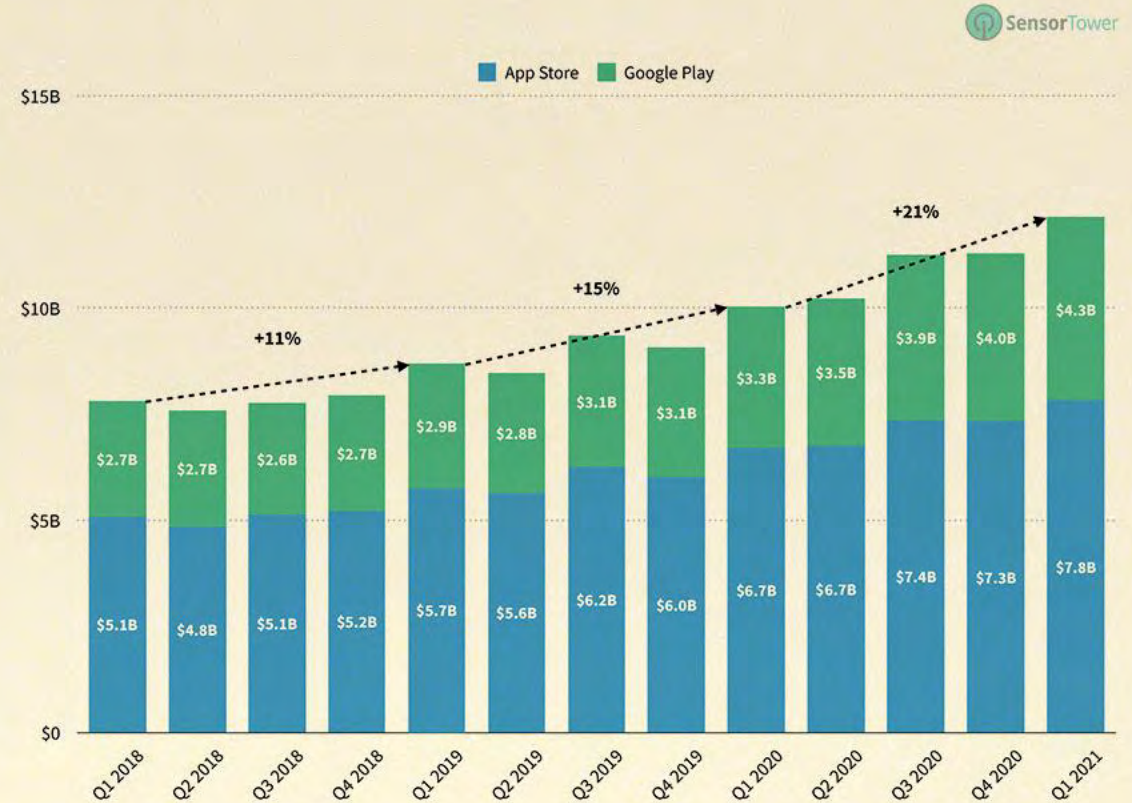
### Global Game Revenue Surged during the Pandemic

## 2.4 Play to earn



Players kill monsters at normal maps and have a chance to collect **COGI** - **COD** - **NFT ITEM** that have level equal to monsters' level. However, to balance the 2 factors of "Play 2 Earn" and "Play 4 Fun", the item drop rate will have a time limit.



Hunting BOSS to receive **COGI**, **COD** & **NFT ITEM**  
There are 3 main boss hunting activities:

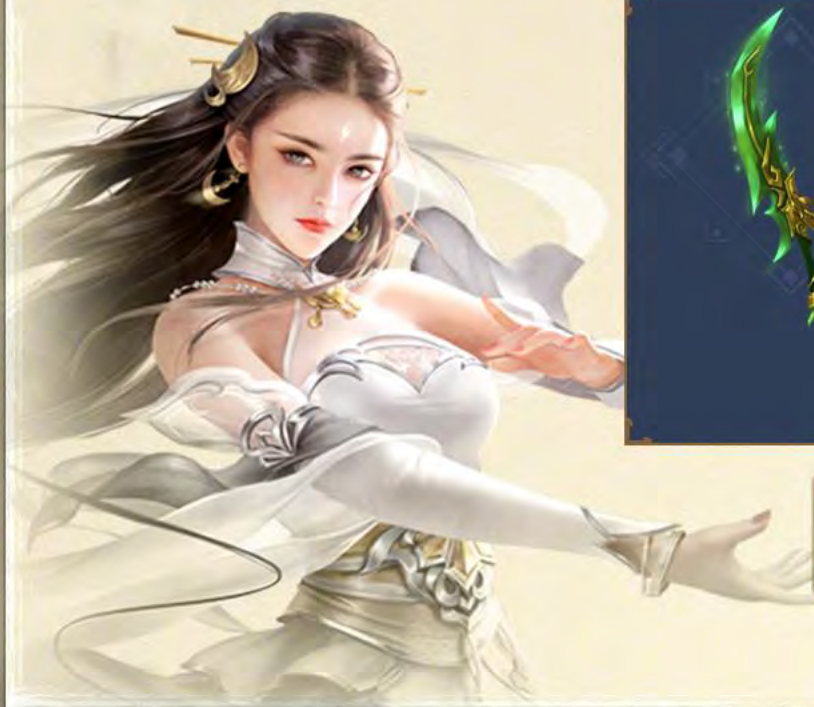
